The Report of the Church Treasurer was accepted as read; the Report of the Church Clerk was accepted as prepared.

#### Old Business

Regarding the American Bible Society booklet on the Gospel of John, suggested for our 90th Anniversary, the cost of this is \$300 for 1000 pamphlets. Motion was made that 1000 booklets be ordered (this will have the picture of the church in one spot, name and address on another spot), these to be distributed in an organized manner in the neighborhood under the chairmanship of Jerry Nendel, by Highway's young people and some from VFCC. Motion seconded and carried.

Bob Wittik (Chi Alpha) will be in one of our services to give details of his ministry. Relative to the plans for this church for the College-Career people, it was moved that we try this outreach - motion seconded and carried. This outreach will be at noon on Thursday; tickets will be distributed by our College-Career young people, the church will supplement cost (probably \$10 to \$15 per week), a charge of 49¢ will be made, it will be monitored in the church, Sisters Albina Jamison and Nadine Dziejowiec will assist with the luncheon.

The Nominating Committee will meet Sunday evening, March 4th, in the Pastor's Study to consider candidates for S.S. Supt. and Asst. S.S. Supt.

Letters from Rita and Al Kelley, giving reasons for their leaving Highway, were read by Brother Picazio at the request of the Pastor. Pastor felt he had counseled the Kelleys all he could previously and had suggested they go to Pastor Menaldino. Since Rita and Al need so much help at this time, it was decided that Brother and Sister Sakash, Brother and Sister Picazio should visit Rita with the purpose of helping, counseling, etc.

The meeting of the Membership for discussion on the REvision of the Manual is set for Sunday, April 29th.

#### New Business

The Deacon and Deaconess Boards have asked for a restoration of the Benevolence Fund, used in ministering to the various needs of the people. This was approved. Envelopes will be obtained and the word "Benevolence" stamped on them to facilitate giving; guide lines for distribution of funds will be sought, announcement will be made in the church bulletin concerning the Fund.

Letter of Transfer was granted to Paul and Mary Larsen (brought into membership in the year 1975), at their request, to First Baptist Church, Cape May.
