The Pastor presided, opening the meeting with prayer.

The Pastor brought up the question of a spring campaign, stating that he had communications from Evangelists asking if we would consider one, as follows: Brother and Sister Pierce, of Canada; Brothers Carter and Somerall, Brother and Sister Perks, Brother Yeager and Brother Tubby.

It was the concensus of opinion that we are greatly favored by having as our Pastor one of the best Evangelists that can be found and as the District Council meeting is very near, and there is a possibility that Brother Carter may be available for some Bible Teaching, that the Pastor write to Brother Pierce and tell him that we are unable to extend an invitation for special meetings at the present time, and the matter prayerfully with the Lord.

The Pastor stated that Brother Bell and Brother Brosky had been unable to go with him to Brother Anderson's at the time appointed, and that he himself had gone out to investigate, and found the chicken house completely demolished, but much material might be salvaged to rebuild.

During the discussion several suggestions were made,- That the Board of Deacons and Deaconesses be given the authority to ask for a special offering; that the Pastor make a public statement with reference to the need, by name, and ask if anyone felt to voluntarily contribute to see a committee, to be appointed, thus relieving the church of responsibility; that those who can use hammer and saw volunteer to assist.

Finally it was moved by Brother Bell, seconded by Bro. Spain, that the Pastor ask for voluntary manual labor to assist in rebuilding, and that the financial aid be left with the Board of Deacons and Deaconesses.

The Pastor asked that the different Boards select their nominee for Deacon, to fill the place of Brother Laverack, who resigned, in order that there may be an election at the next meeting.
