Re Richards Estate

Dear Mr. Smith:

Mr. Richards has just authorized me to offer his property
to any religious organization on the following terms:

The organization will buy the property at the full price
of \$40,000.00. This money will be put in a special trust account and
upon the death of the surviving spouse will be refunded in full to
the organization. Mr. Richards, who as you probably know, has a
serious heart condition, does not expect to be with us very long and
is only interested in the income from this trust fund for his wife
until her death. There are no children, or close relatives in the
family, and as you know, they are quite wealthy people. Therefore,
he has decided to make this gift of this estate to the organization
that has use for it.

If the full \$40,00 is not available, he will leave a mortgage
of \$20,000 or \$25,000 in the property at $4\frac{1}{2}\%$ interest. In this event,
you understand the amount of cash invested will be refunded and the
mortgage will be satisfied.

This is an offer made in good faith and your attorneys will
see that everything is in order so that there is no question about the
refund of the full purchase price.

I am making this same offer to the other Protestant
denominations in our town. The Richards' also want me to make the
same offer to the Catholics, who I know will accept immediately.
However, I intend to wait one week to give the Protestants first
opportunity. Please contact your committee and advise me as soon as
possible.
