You would be among your friends. It is my suggestion that you seriously consider making application to the home in Philadelphia. We would be glad to continue your support you receive monthly if you were to go into the above home.

We really do feel sorry for you and regret that you did not accept our offer to receive you into the home in Florida a year ago. I knew then that you were making a serious mistake, but there was nothing we could do about it since you had engaged a lawyer to write and restrain us from insisting you go to the home. I realize in your physical condition it was hard for you to think for yourself, and we do not in any way hold this against you. This is proven by the fact that when you decided to remain at home, we granted you monthly support so that you could have the necessities of life.
