

March 10th, 1958

At a regular meeting of the Board of Trustees, held March 10th, 1958, the following were present. Bros. Roberson, Griffith, Ambrose, Dron, MacPherson and Simokat.

The Minutes of the previous meetings were read, followed by the Treasurers report, which were accepted as read.

A brief report was submitted by the House Committee, followed by a request for the Board to secure a refrigerator for the dining room in the church. It was suggested that this request be brought to the attention of the members of the church, as an announcement from the pulpit, as well as posting such a notice on the bulletin board rear of the church, to ascertain whether any of the members had a refrigerator, in good working order, which they would care to contribute to the church.

There was considerable discussion again on the inadequacy of parking facilities in the vicinity of the church. It was brought to the attention of the Board that quite a few members had been using the facilities of the parking lot adjacent to Linton's Restaurant on Sundays, and that this was done without official permission by the proprietor of the lot. To get such official permission it was suggested that the Board contact the proprietor, and if necessary offer some remuneration for the privilege of using this lot on Sundays. Moved by Bro. MacPherson, and seconded by Bro. Dron.

An estimate was submitted by Bro. Roberson, from the Dubin Renovating Service, Inc. - N. 6th Street, Philadelphia for upholstering the davenport in the ladies' lounging room and nursery, at a cost of \$153.00. It was duly moved and seconded that we give these people the contract to have this work done at this figure; material to be furnished an imitation leather, brown color.

On motion made, duly seconded, it was agreed to increase the car gas allowances on Bro. Roberson's and Sister Alta Shiner's cars, as follows;

Bro. Roberson - from \$50.00 to \$60.00 per month
Sister Alta Shiner - From \$20.00 to \$30.00 per month

On motion made by Bro. Dron and seconded by Bro. Simokat, it was agreed to purchase a typewriter, to be used by Sister Alta Shiner, and her Crusaders, in connection with their work on cutting stencils. Cost approximately \$100.00.


On motion made by Bro. Ambrose, seconded by Bro. MacPherson, it was agreed to allocate \$200 to the Highway Church Choir, to be taken over the calendar year, for use in their choir activities over the year.

Bro. Tom Griffith made a motion, seconded by Bro. MacPherson that we give Bro. Chas. Hunt fifty (\$50.00) dollars per month toward his support in his missionary activities in North Carolina, with the understanding that any monies contributed by the Sunday School class be refunded to the Church Missionary Treasury.

The matter came up again for getting carpet runners for rear of the auditorium. It was suggested that Bro. Roberson contact Bro. Nick Castaluchi to see if he could furnish such runners to meet the need in the rear of the auditorium.

As there was no further business before the Board the meeting adjourned with a closing word of prayer.
