

April 14th, 1958

At a regular meeting of the Board of Trustess, held April 14th, 1958, the following members were present; Griffith, Dron, Ambrose, MacPherson, Schmiel, Heintz, Simokat, and the pastor, Bro. Roberson.

After an opening word of prayer by Bro. Heintz, the Minutes of the previous meetings were read, followed by the reading of the Treasurers report; both were accepted as read.

There was a report by the House Committee that there was a bad leak on the roof, over the dining room (18th Street side). It was moved by Bro. Griffith, seconded by Brother Ambrose that immediate steps be taken to have this roof repaired; also to check into the matter as to whether any written guarantee by the roofer who did the work several years ago was on file.

It was brought to the attention of the Board that some additional work was done in upholstering by the Dubin Renovating Co. as reported in the Minutes of March 10th, which brought the bill up to \$170 instead of \$153.00.

The Board expressed their appreciation for the very fine painting job done by the Mens' Fellowship of Highway Mission of the Sunday School auditorium, and it was moved and seconded that a letter of appreciation and thanks be sent by the Trustee Board, in behalf of the entire church membership, to the Mens Fellowship.

On motion duly made and seconded, Bro. Griffith was authorized to procure an electric clock for the church dining room, at the request of Bro. Leon, the sexton.

Bro. Tom Griffith reported that he had contacted the proprietor ^{Mr. Levin} of the parking lot, adjoining Lintons Restaurant. Mr. Levin agreed that an arrangement could be worked out whereby we could use the facilities of his parking lot, on a rental basis for Sundays. Bro. Dron made a motion, seconded by Bro. Simokat, that we negotiate with Mr. Levin for rental of this lot on Sundays, and suggested that the rental fee be \$35.00 per month.

Bro. Roberson brought to the attention of the Board an emergency financial need of Bro. Leon, in connection with the recent surgical operation of his wife. It was pointed out that there was a balance due the hospital of \$200 which Bro. Leon was unable to meet. On motion made by Bro. Roberson and seconded by Bro. Dron, the Board unanimously agreed to take care of this need for \$200. Bro. Leon was to get \$200 in payments OF \$25 per week over an 8 week period. After the \$200 had been paid, Bro. Leon was to receive an increase in salary of \$5.00 per week.


✓ It was moved and seconded that we make our annual contribution of \$25.00 to the American Bible Society. Moved by Bro. Dron, seconded by Bro. Simokat.

It was brought up by the House Committee the need for improving and beautifying the lawns and grass plots, in front of the church, as well, as along 19th Street. It was suggested that the Mens Fellowship take care of the work, and necessary steps be taken to procure any grass and shrubbery, including barberry hedge for these lawns. Duly moved and seconded.

Also moved and seconded that Bro. Ambrose procure necessary fertilizer and grass seed for the church parsonage. This work to be done at the discretion of Bro. Ambrose.

As there were no further matters to discuss, the meeting adjourned with a closing word of prayer by Bro. Roberson.
