The Board of Trustees also decided to have the paneling in Sunday School rooms done by Davis at a cost of \$600.00 dollars.

Bro. and Sis. Korn were given \$100.00 dollars to go to Eastern District Council in Harrisburg. Meeting to last two nights. Bro. and Sis. Korn to return what they dont use.

Bro. Ambrose to purchase a lawn mower for Parsonage at a cost of \$69.00 dollars. Also to buy an edger for Parsonage.

A motion was made and seconed that we take on the support of Norman Jay Cole who is working out of Teen Challenge and is in need of financial help at this time. It was decided to give him \$50.00

dollars a month for one year through Springfield. To start the begining of June. The Board also decided to send him \$100.00 dollars as of now.
